CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **B.E.A. College of Education, MCC 'B' Block, Davanagere – 577004, Karnataka** vide SRC vide order no. F. F.KAR/B.Ed/15 /SRO/NCTE/2000-2001/914 dt. 10.07.2000 for conducting (**B.Ed.**) course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. **AND WHEREAS**, the SRC in its 244th meeting held on 9th – 11th May, 2013 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No. APS03341/B.Ed/KA/2013-14/52308 dated 17.06.2013 was issued to the institution.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations.

4. **AND WHEREAS**, the permission to restore/continue & shift the institution to its new permanent premises at **S. Nijalingappa Layout, 2nd Main, 11th Cross, Davanagere -577004, Karnataka** vide order no. F.SRO/NCTE/APS03341/B.Ed/KA/2015-16/63522 on 27.04.2015 was issued to institution.

5. **AND WHEREAS**, a revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units of 50 students** each from the academic session 2015-16.

6. **AND WHEREAS**, the SRC in its 321st meeting held on 28th & 30th September, 2016 considered the request for one unit. Accordingly, as per the decision of SRC a letter was issued to the institution on 15.10.2016. The institution has submitted reply on 18.09.2020.

7. **AND WHEREAS**, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the reply and decided to issue last reminder letter. Accordingly, as per the decision of SRC last reminder letter was issued to the institution on 21.10.2020. The institution has submitted reply on 07.11.2020.

8. **AND WHEREAS**, the SRC in its 401st meeting held on 11th - 12th August, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/ APS07930/B.Ed./AP/2020 dated 06.11.2020 was issued to the institution.

9. **AND WHEREAS**, the decision taken in its 401st meeting of SRC has been reviewed by the SRC in its 403rd meeting held on 18th – 19th October, 2021 and the rectified decision is reproduced below:-

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution B.E.A College of Education, Survey No. 1179/6, 2nd Main 11th Cross, Nijalingappa Layout, Davangere District-577004, Karnataka for B.Ed. programme for 1 basic unit of 50 students."

10. NOW THEREFORE, this order is issued permitting the institution i.e. **B.E.A College of Education, Survey No. 1179/6, 2nd Main 11th Cross, Nijalingappa Layout, Davangere District-577004, Karnataka run by Bapuji Educational Association, S. Nijalingappa Layout, 2nd Main, 11th Cross, Davanagere, Karnataka-577004** for continuation of recognition for **B.Ed. Programme for two years duration with an annual intake of (1 basic unit) of 50 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
